## STATEMENT ON EU REACH PROVISIONS

This statement reflects a common understanding on the EU REGULATION (EC) No 1907/2006 OF THE EUROPEAN PARLIAMENT AND OF THE COUNCIL of 18 December 2006 concerning the Registration, Evaluation, Authorization and Restriction of Chemicals (EU REACH) as well as MOCAP's specific situation regarding EU REACH. It outlines the various obligations applicable to MOCAP's products and the requirements regarding articles. Specifically, EU REACH requires us:

- To inform recipients if an article placed on the European market contains a Substance of Very High Concern (SVHC) in excess of 0.1% by weight. SVHC's are identified on the European Chemical Agency (ECHA) website.
- To notify ECHA if an article contains an SVHC in excess of 0.1% by weight and the total amount of the SVHC present in all articles produced or imported to the European market exceed one metric ton per year.
- To cease shipment of articles containing EU REACH Annex XIV Substances Subject to Authorization unless authorization has been obtained and,
- To cease shipment of articles containing EU REACH Annex XVII Substances when restrictions apply

Having evaluated supplier responses MOCAP has, to the best of its knowledge and belief determined that:-

- MOCAP's products do not contain any substances within the entries on the SVHC Candidate List in excess of 0.1% by weight per article. **Mocap will continue to monitor this list and will inform recipients if this statement changes**
- As MOCAP's products do not contain any substances within the entries on the SVHC, annual reporting to ECHA is not required.
- MOCAP's products do not contain any of the substances within the entries subject to authorization under EU REACH Annex XIV as published by ECHA. Mocap will continue to monitor this list and will inform recipients if this statement changes.
- Mocap however do use Di-Iso-Nonyl Phthalate – (DINP) – CAS 28553-12-0 and 68515-48-0 EINECS No 249-079-5 and 271-090-9 during its manufacture of vinyl dip moulded products. This substance appears on the Annex XVII of the EU Reach Regulations. Conditions of Restriction are:-
  - Shall not be used as substances or in mixtures, in concentration greater 0.1% by weight of plasticised material, in toys and childcare articles which can be placed in the mouth by children.
  - Such toys and childcare articles containing these phthalates in the concentration greater than 0.1% by weight of plasticised material shall not be placed on the market.
  - For the purpose of this entry "childcare article" shall mean any product intended to facilitate sleep, relaxation, hygiene, the feeding of children or sucking on the part of the children.
